

Art/Non-Profit/Commercial (non-Food) Vendor Rules & Conditions

16th Fell's Point Privateer Festival

Saturday, April 18, 2020 (Rain or Shine)

10:30 a.m. to 8 p.m.

Food vendors should use separate application.

IMPORTANT: Please note that the selection process is juried and vendor applications are subject to Fell's Point Main Street (FPMS) committee approval. There are a limited number of vending opportunities/categories and Fell's Point "brick & mortar" businesses have the right of first refusal in every category. Preference will be given to vendors displaying/selling handmade items, nautical themed merchandise and merchandise with historical reference. We are not accepting any beverage/alcohol vendors and commercial entries are limited.

PROCESS: All applications will be approved within 48 business hours. If approved, applicants will receive an invoice with payment information. If not approved, applicants will receive email notification. Payment must be made before booth space is confirmed and reserved. Deadline to submit applications is April 10, 2020. Rules and Conditions:

1. Vendors must be at least 18 years of age.
2. Event will be held rain or shine, and no refunds will be issued in the event of inclement weather.
3. Each exhibitor must provide their own tent, tables, chairs display racks, etc... Tents must be properly weighted down so they don't blow over. All spaces are approximately 10' X 10'. Spaces are marked, preassigned and non-transferrable. Display equipment may not extend beyond the boundaries of the assigned space (including stakes or poles for tents). No electricity is available. Whisper or Quiet Run generators are permitted. No WiFi is provided.
4. Please upload photographs of your items. Applications will be reviewed, and applicants will receive a notification of acceptance with an invoice.

5. The fees for booth spaces are:

6. Space assignments will be given the day of the festival at check-in. Directions to the event location and vendor load-in instructions will be provided via e-mail 48 hours before the event. Exhibitors will be expected to set up between 7:00 a.m. & 9:00 a.m. Please obey the unloading directions.

7. There is no dedicated parking for exhibitors. On-street parking is available and parking garages are nearby. FPMS will not be responsible for parking tickets received in violation of any parking regulations. No vehicular traffic is allowed in festival footprint after 9 a.m. or before 8 p.m. on the day of the festival.

8. Each exhibitor is responsible for collecting Maryland Sales Tax on all sales made during the event. This tax should be added to the price of items sold.

9. FPMS does not guarantee exclusive sales rights to any vendor or product unless written exception is negotiated.

9. FPMS will not be responsible for loss or damage to persons or properties including displays/works on exhibit. Vendors need to provide a certificate of insurance and it can be uploaded with your application.

10. For and in consideration of permission to participate in the festival activities, the individual, group or organization clicking or signing this agreement is to assume the risks and agree to release Fells Point Main Street, its members, and all persons organizing, sponsoring or assisting the festival from any and all liability losses, and or claims arising out of participation in the 16th Annual Privateer Festival.
